ONE-STOP COMPLIANCE

PPSWG's subsidiary MED-Project is **the only program operator with approved household medicine take-back plans in all jurisdictions** with operational mandated producer-funded take-back legislation.

MED-Project implements proven and reliable compliant take-back programs for household drugs and sharps, **keeping operational costs down, not maximizing profits**.



COST-EFFECTIVENESS

The representatives of member companies that make up our Board set priorities and approve program budgets: **PPSWG and MED-Project have no incentive to expand mandated take-back programs, and make managing cost and efficiency a top priority**.

Government mandates have grown to cover a population of more than 91 million residents, and our aim is to provide compliance in the most cost-effective manner.
